Age, gender, religious belief or any other protected characteristic are not considered when selecting our clients. No user or prospective user will be subject to any detriment on the grounds of any protected characteristic, at any time.

Cancellation Terms

If you need to cancel a lesson or report an absence, please correspond as soon as possible via email at finchnest.tutoring@outlook.com. Email is requested so there is written proof of your instruction with a time stamp. Lessons that are cancelled by the client with less than 48 hours' notice are charged in full. Absence from lessons without notice will still be charged in full.

Termination of Tuition Terms

Our termination policy requires that, once you have provided notice to terminate lessons, you are required to take two further lessons with the tutor in the 14 days after you give notice.

If you choose not to take two lessons after you give notice of termination or do not respond to the tutor within 7 days, the tutor will assume that you no longer wish to take tuition and is liable to charge for these two lessons. Arriving Late to a Lesson

How to Pay

Invoices are sent via email after each lesson. Payment details are included as part of the invoice and payment is required via Bank Transfer, using the reference required written on the invoice.

Please pay your invoice within 5 days. If an invoice is not settled within 5 days, clients will receive a payment reminder and Finch Nest Tutoring (part of Finch Nest Preschool Ltd) will begin pursuing monies owed. Late Payment Charges

For an invoice overdue by 5 days or more, we reserve the right to:

• Stop tuition until the invoice is settled.

For an invoice overdue by 10 days or more:

- Charge an interest rate of 10% per month on the outstanding invoice.
- Charge an administration fee of £25 for the collection of commission payment.

In the unlikely event that a bill is not paid, Finch Nest Tutoring (part of Finch Nest Preschool Ltd), will pass the matter onto Creditreform. Creditreform may add additional charges to recover monies owed.

Registration Fee
